STEWARDSHIP and FINANCIAL REPORT - THRU JUNE

We have roughly \$575K in unrestricted funds available as of today, September 9, 2024. This includes Operating Cash \$182K, Zutes Maintenance \$28K, PayPal \$5K, and approximately \$360K in CD's/Money Market accounts. Please note, as discussed in our Spring 2023 meeting, we consolidated funds into the Operating Cash account and closed the following checking accounts: Building, Jempelis, Festival, and GOYA. The Sage Rutty statement has a list of our CD's. Note, the balance of the Sage account, roughly \$122K represents restricted funds as of July 31st.

The internal Deposit Reports summarize all our financial data for the bookkeeper. For example, as of June 30th, Stewardship income was \$136,483 (\$30,195 in online giving, \$105,088 in general deposits, and \$1,200 through PayPal). By comparison, as of June 30, 2023, we posted \$171,844 in Stewardship (see attached report).

Our efforts to secure reliable bookkeeping services continues to face roadblocks. We decided to use the Binghamton based bookkeeper through 2024 but just found out that the person handling our account has left the firm. We are onboarding another person currently and should have the records in better shape by the next meeting.
